## **AUTHORIZATION**

Degree programs of study offered by FIRE School of Ministry have been declared exempt from the requirements for licensure under provisions of North Carolina General Statutes (G.S.) 116-15(d) for exemption from licensure with respect to religious education. Exemption from licensure is not based upon any assessment of program quality under established licensing standards.

Certificate and/or non-degree programs offered by FIRE School of Ministry have been declared exempt from the requirements for licensure Under provisions of Article 8, §115D of the North Carolina General Statutes, for exemption with respect to religious institutions. Exemption from licensure is not based upon any assessment of program quality under established licensing standards.

FIRE School of Ministry (FSM) is authorized to operate in North Carolina under FSM's corporate charter, filed with the State of Florida. FSM's Board of Directors is responsible for all policy-making decisions and for the management and administration of the school, in accordance with the charter.

#### **AFFILIATION**

FIRE School of Ministry is an outgrowth of F.I.R.E. (Fellowship for International Revival and Evangelism) and provides affiliation with a missions-sending organization for those desiring to be missionaries

## **ADMISSIONS**

#### **GENERAL INFORMATION**

FIRE School of Ministry receives applications at any time. All applicants must meet the following requirements to receive consideration for admission:

- Applicants must live in accordance with godly principles, as stated in the FIRE Student Commitment to Excellence.
- Applicants must have completed High School via diploma or GED (or graduated with an equivalent level of education in another country).
- Age: Applicants must be at least 17 years of age by the first day of the term in which they wish to enroll.
- Applicants must complete the online application process.

## APPLICATION PROCESS

The FIRE School of Ministry application process consists of the following.

Student Application: Complete the online student application available on our website.

<u>Recommendations</u>: Provide FSM contact information for a personal and a pastoral recommendation. (Applicants unable to provide recommendations due to being newly saved or having recently moved should contact the FSM office. If provisionally accepted without recommendations, the student will be allowed to take a specified number of credits, while the student becomes involved in a local church and submits recommendations by a future deadline.)

<u>Transcript request:</u> The student must submit their academic transcripts (see below for more information).

Fee: Nonrefundable \$25 application fee

<u>Evaluation</u>: When the Admissions Office has received all application components, the application will enter the Evaluation Process and will be reviewed. Applicants will receive notification of determination by email.

Documents submitted to FSM as part of the application/evaluation process will not be returned.

## **REQUIRED TRANSCRIPTS**

## **High School Transcripts**

Applicants must request their official High School transcripts (or proof of GED), be sent directly to FSM from the institution. Official electronic submissions from the institution will be accepted.

High School transcripts which are not in English must be accompanied with a certified English

translation from a recognized translation service. Additional details are provided in the online application.

Applicants whose High School transcripts are not in English, but who have graduated from an English-speaking college, may in some cases be allowed to submit their college transcripts in lieu of having their High School transcripts translated.

## Home School

Home school applicants must have an official transcript from a home school agency, college, or a GED certificate. For homeschoolers not affiliated with a nationally organized home school agency, FSM reserves the right to determine the acceptable requirements for each home school applicant.

## GED/High School Diploma in Progress

At the discretion of the Academic Department, an applicant who has not received a high school diploma, GED, or completed an approved home school program, may be allowed to enroll in a select number of FIRE School of Ministry credits. To be considered, applicants must intend to complete their GED or High School program within the next 12 months, and must provide FSM with an official copy of their High School, home school, and /or GED progress to date. Such requests will be evaluated on a case-by-case basis.

#### TRANSFER OF CREDIT

FIRE School of Ministry will consider requests to transfer credits from other colleges into FSM on an individual basis. Students should be aware of the following regarding transferring credits:

- FSM will consider Bible, Theology and Ministry related credits from Christian Bible Colleges and Seminaries, on an individual basis.
- Students may be allowed to transfer up to 6 credits from English, Writing, and History courses, towards the elective requirements of the Associate in Practical Ministry program.
- If the applicant has their own copy of their transcripts, they can email a copy to the Registrar in order to receive a preliminary evaluation.
- In order to formally be considered for transfer of credit, the student must have an Official copy of their transcripts be sent to FIRE School of Ministry from the college. Transcripts which are not in English must be accompanied with a certified English translation from a recognized translation service.

For information regarding transferring FSM credits to other schools, please see the "Accreditation/Articulation Agreements" section.

## READMISSION AND ENROLLMENT

Students who are not enrolled in any FSM classes for more than 12 months must submit a readmission form. Students who are not enrolled for more than 18 months, must resubmit the entire application.

## STUDENT POLICIES

It should be the desire of every believer to live in a manner that is pleasing to God (Eph 5:8-10; 2 Cor 5:9-10), and to become more like Christ (2 Cor 3:17-18; Rom 12:1-2).

Part of the training students receive at FSM involves developing the private habits and public lifestyle that befit a minister of the gospel. During registration students must complete a Student Commitment to Excellence, demonstrating their agreement to abide by FSM's academic, moral and social standards.

### STUDENT COMMITMENT TO EXCELLENCE

Each FIRE student is expected to commit to the following standard of excellence:

- To grow in my relationship with God through prayer, study of the Word, worship, and devotion (2 Tim 2:15; Eph 6:18).
- To attend a local church, where I can fellowship with other believers (Heb 10:25). \*
- To conduct myself in moral, ethical, and spiritual purity according to God's Word (1 Tim 4:12).
- To cultivate positive social relationships, avoiding gossip, and all forms of harassment. This includes using social media and other communication tools in a responsible manner, not posting lewd, vulgar, or harassing content (Eph 4:29; Prov 16:28).
- To conduct myself as a responsible citizen (Rom 13:1).
- To avoid the abuse of alcohol, avoiding drunkenness, alcohol addiction, and underage drinking (Eph 5:18).
- To avoid illegal drug use, tobacco products, and recreational drug use (Romans 6:13; 1 Cor 6:12).
- To pursue sexual purity, in agreement with the biblical view that sexual activity is to only occur within God-ordained marriage between a naturally born man and a naturally born woman (1 Cor 6:18-20; 1 Thess 4:3-8; Matt 19:4-6).
- To pursue academic excellence and integrity.
- To conduct myself in a responsible manner when interacting with FSM staff, faculty, and fellow students, as well as during practical ministry requirements.
- To abide by established school standards and academic guidelines.

\*Students who find themselves in situations where this is not possible (for example living in a region where there are no Christian churches), are encouraged to participate as much as possible in FSM online meetings.

Students with questions about these commitments as they relate to local laws/customs or their personal situations may contact the FSM staff for clarification.

#### ESSENTIAL DOCTRINES

While there are many areas of doctrine where fellow Christians often differ and can have constructive debate, there are also beliefs that are foundational and essential.

In order to participate in practical ministry requirements, FSM students must not promote beliefs contrary to fundamental, essential teachings of the Christian Church, including: the triune nature of God; that salvation is only found through Jesus Christ; that both the Old and New Testaments are the inspired Word of God; that marriage, as ordained by God, is only between a naturally born man and a naturally born woman; that life begins at conception.

## SCHOOL STANDARDS AND GUIDELINES

### Announcements

Announcements are generally emailed to the students and posted in Populi. Students are responsible for all information communicated through the announcements.

## Church Service Attendance

FSM students are required to attend a local church body. Students are also encouraged to become part of a small group or similar gathering at your local church. Students who find themselves in situations where this is not possible (for example living in a region where there are no Christian churches), are encouraged to participate as much as possible in FSM online meetings.

## Health care

Each student is fully responsible for his/her own medical expenses and for those of family members. FIRE School of Ministry cannot assume any financial responsibility for health services rendered to FIRE students and their family members.

#### Fasting

Students should contact their primary care physician before beginning a fast, to ensure the student is physically capable of the fast and enters and exits the fast appropriately.

## Solicitation of Speaking Engagements

Solicitation of speaking engagements at churches using your status as an FSM student is not permitted.

## Pastoral Care

It is important for FSM students to be part of a local church body, to receive encouragement, support and pastoral care from fellow believers and leaders in your area. Students should also be aware that FSM is not able to provide professional, long-term counseling services to individual students.

#### Harassment

Any form of harassment by FSM students, employees or volunteers is completely unacceptable. A partial list of unacceptable behavior includes:

- Profanity, obscenities, vulgar gestures, slander, public humiliation, threats.
- Sexual harassment of any kind, including: requests for sexual favors, unwanted touching, inappropriate or obscene remarks or text messages.

Any harassment should be reported immediately to the FSM Administration. If the student fears an imminent threat to their safety, they should first contact the police.

## DISCIPLINARY PROCEDURES FOR NON-ACADEMIC VIOLATIONS

Each student should carefully read the policies and rules contained in the School Catalog. If a student's conduct or behavior results in a serious violation of FSM's standards, including the Student Commitment to Excellence, the following disciplinary procedures will apply:

- Depending on the severity of the infraction, the student may be given a warning, placed on probation, or, for more serious offenses, be dismissed from school.
- If the student is placed on probation, the student will be required to meet via phone or Zoom video conference with an FSM staff member to discuss accountability. The student will continue to be able to take classes, with possible restrictions. A lack of improvement during the probationary period may result in dismissal.
- If dismissed, the student will be given re-enrollment requirements (if applicable). If reenrollment requirements are successfully completed, the student will be allowed to reenroll.
- A student may submit an appeal for any nonacademic dismissal within 48 hours of dismissal. The appeal must be emailed to the Registrar, with detailed documentation verifying the student's circumstances. The President will review any such appeals and make a final determination.

## **COMPLAINTS/ GRIEVANCES**

Any grievance with FIRE School of Ministry should be addressed to the appropriate department. If unsatisfactorily resolved, the grievance may be addressed to the Administrator.

The State Authorization Unit of the University of North Carolina System Office serves as the official state entity to receive complaints concerning post-secondary institutions that are authorized to operate in North Carolina. If students are unable to resolve a complaint through the institution's grievance procedures, they can review the Student Complaint Policy (PDF) and submit their complaint using the online complaint form at Student Complaints Site

## FINANCIAL INFORMATION

## **PROGRAM COSTS**

Tuition: \$85 per Credit Hour

Registration Fee: \$30 each Academic Quarter

Textbook Costs: Varies

All tuition and fees are subject to change without notice.

#### **Total Costs**

The Associate in Practical Ministry requires 60 total credit hours. If the student completes the program in two years, the average cost of Tuition and Fees each three-month Quarter would be \$668.

The total cost of Tuition and Fees for completing the Associate in Practical Ministry degree in two years would be \$5,340. After their first year (30 credit hours), students can also earn the Certificate in Practical Ministry. FSM estimates students will spend on average \$10-\$20 on textbooks per credit hour.

## Part-time

Students may take classes at their own pace. Part-time tuition remains the same per credit hour. The Registration Fee also remains the same for each three-month Quarter the student registers for classes.

#### REFUND POLICY

A student who withdraws from a class will receive a refund of tuition according to the following schedule:

- Within 7 days of receiving access to the online course materials: 70%
- Within 14 days of receiving access to the online course materials: 50%
- Within 21 days of receiving access to the online course materials: 20%

After 21 days no refund will be issued. Refunds will be issued within ten business days and will be credited back via the original payment method. Fees are non-refundable.

#### FINANCIAL PROBATION

Failure to fulfill all financial obligations to FIRE on time will result in a student being placed on financial probation. This may result in the student being unable to register for new classes, electives, or receive school documents such as report cards, diplomas, and transcripts.

#### **TAXES**

FSM is not eligible for Federal Student Aid and does not issue the 1098-T form. It is FSM's belief that, with possible rare exception, tuition paid to FSM does not provide personal tax benefits in the United States. You may go to the IRS website at www.irs.gov for more information. FSM endeavors to keep its tuition as affordable as possible.

## **COURSE LOAD**

Students may take as few as one course in an academic term. Tuition per credit hour remains the same whether the students is full-time or part-time.

## **ACADEMIC POLICIES**

## STUDENT INFORMATION SYSTEM (POPULI)

FIRE School of Ministry uses Populi for its student information system. Populi is a web-based system, and students will be given their own login to the student portal. Students will be required to access Populi for various class and school requirements, including taking tests, uploading assignments, completing online forms, and checking their grades.

## **VIDEO CONFERENCING (ZOOM)**

FIRE School of Ministry uses Zoom for video conferencing, including faculty mentoring sessions. See <a href="https://zoom.us/">https://zoom.us/</a> for information regarding Zoom software.

## REGISTRATION

To register, each student must have no pre-existing unpaid financial obligations to FSM and must have enrolled in a class within the past 12 months. Students who are not enrolled for more than 12 months should consult the Readmission and Enrollment section. Upon acceptance to FSM, students will receive instructions for how to register for classes each term.

#### TRANSCRIPTS AND STUDENT RECORDS

## Transcripts and Proof of Enrollment

Since student records are confidential, academic record transcripts are provided only upon student authorization. Transcripts cannot be issued if the student has an outstanding balance with FSM. Requests for letters verifying enrollment at FSM should be made to the Registrar.

Students may request transcripts online, or by completing a Transcript Request form or by submitting to the Registrar the following:

- Name and address to whom the transcript is to be sent
- Indication if the transcript is to be held for current term grades
- Student's full name, including maiden name, if applicable
- Date of birth
- Student identification number
- Student's signature

## **Confidentiality**

FIRE School of Ministry maintains the confidentiality of student records. Any student with a question about his/her records may contact the Registrar.

## **Directory Information**

FIRE School of Ministry may release directory information to third parties without written consent by the student. FSM considers directory information to include the following: student name, address, telephone number, e-mail address, date and place of birth, field of study, dates of attendance, degrees and awards received, the most recent previous educational agency or institution attended by the student, enrollment status, photograph, and participation in officially recognized activities. This information may be released without the student's written authorization. However, students may withhold directory information by completing the Request to Withhold Directory Information form.

## Nondirectory Information

Since nondirectory information is confidential, such information will only be released with the student's written authorization. Students are given the option to release this information to specific person(s) by completing the Student Information Release form.

However, information may be released to the following:

- School employees with a legitimate "need to know."
- Persons who need to know in cases of emergency to protect the health and safety of the student or other individuals.
- As otherwise legally required.

#### WITHDRAWAL

Students who withdraw from individual classes will receive a "W" grade for all classes from which they withdraw, provided they adhere to the following guidelines:

- The student withdraws by the deadline listed in the Academic Calendar for the term enrolled.
- To withdraw, the student must complete the Drop/Add form, available online in Populi.
- A student withdrawing after these deadlines must apply for and receive approval from the Registrar to be eligible for a "W" grade. Students who withdraw after these deadlines without approval will receive a "WF" grade for all classes in progress.
- Students who withdraw entirely from FIRE School of Ministry must withdraw by the deadlines above in order to receive a "W" grade for their individual classes.

See the Refund Policy section for complete details concerning tuition refunds.

#### **DISMISSAL**

Students who are dismissed will receive a "DM" designation on their transcripts for all classes in progress at the time of dismissal. Refunds will be issued to a dismissed student at the same rate as students who withdraw from FIRE School of Ministry.

## COURSE MATERIALS, AFFIDAVITS & COPYRIGHT

Students will be required to listen to all class material required by each individual course. At the end of the term each student will be required to complete an affidavit, indicating they have done so by the term deadline.

Class materials cannot be reproduced, sold, or distributed to anyone without the express written consent of FIRE School of Ministry.

#### ASSIGNMENTS AND TESTS

## Online Tests

Tests and quizzes for many classes will be offered in Populi. Students must complete and submit the exam within the availability window listed in Populi.

## Make-up Tests

Make-up tests will be given only when the failure to complete the test on time is due to one of the following:

- Emergency/accident or special leaves of absence (e.g., jury duty)
- Personal illness (must be bedridden and unable to complete the test)
- Death of an immediate family member
- Internet or Power Outage in your region

In order to take a missed exam, the student must complete the Make-Up Exam Request Form in Populi within one day of missing the exam. In the case of a severe illness or emergency, the student should complete the form on the first day they are able to do so.

The completed Make-Up Exam Request will be reviewed by the Academic Office. If approved, a time will be scheduled to take the test.

### Assignments

All assignments should be submitted online in Populi. Assignments must be submitted in either Microsoft Word or PDF format. If using another Word Processing solution, please save/export the file as a PDF or Microsoft Word document.

Students should be sure to keep copies of all assignments submitted to FSM. In the event of the loss or destruction of an assignment, or its failure to upload properly, the student may be required to resubmit it.

## Research Paper Guidelines

Students should consult the FSM Guidelines for Research Papers for all papers. Students writing an exegesis paper should also consult the Exegesis Paper Guidelines. If a paper does not meet the Guidelines, it may be returned to the student without a grade, with a deadline for resubmission, and possible grade deduction.

## **Textbooks**

Each course syllabus lists required textbooks. If a required textbook is not available for purchase in the student's country, the student may contact the Academic Department for guidance.

## Course Requirements

Each course syllabus includes a list of Course Requirements. Each course requirement must be completed in its entirety in order to pass the course, even if that requirement amounts to less than 40% of the final grade.

#### Grade appeal process

Students will have 45 days from the date grade reports are made available in Populi to question or appeal a grade by contacting the Academic Department.

#### Grade questions

Students who have questions regarding grades they received for any class, test, or paper are encouraged to email the Department.

## Incomplete grades

The grade of "I" (Incomplete) is given only in extenuating circumstances to students who, with the approval of the Academic Department, have satisfactorily completed a minimum of 50% of the course assignments/requirements, but for unforeseen reasons (personal emergency, illness, or other considerable hardship) have been unable to complete all course requirements.

An incomplete may be recorded for a maximum of one term and is not computed into the student's GPA. Courses for which the student receives a grade of "I" must be completed by the end of the immediately succeeding term or the grade will automatically convert to an "F" on the student's record and will be computed into the GPA.

#### ACADEMIC PROBATION AND SUSPENSION

FIRE School of Ministry seeks to provide quality higher education and, therefore, requires reasonable academic progress. Students who do not make reasonable academic progress will be subject to academic probation or suspension according to the following policy:

- A student enrolled in four or more credit hours who fails to achieve a minimum term GPA of 2.0 will be placed on academic probation for the next term of enrollment of four or more credit hours.
- At the discretion of the Academic Department, the probationary period may continue until the student achieves a minimum term GPA of 2.0 for a subsequent term of enrollment, or achieves a minimum cumulative GPA of 2.0.
- Failure to achieve or maintain a 2.0 cumulative GPA while on academic probation may result in an academic suspension, with re-enrollment at the discretion of the Academic Department.
- The student will also have the option to change to non-degree status.

## Academic Suspension Appeal Process

A student who feels he/she has been suspended unfairly may choose to appeal the suspension. Within forty-eight hours following an academic suspension, a student may submit an emailed appeal to the Academic Department with detailed documentation to validate the appeal. If the Academic Department decides that re-enrollment or continuance requirements (where applicable), have been successfully met, the student may be allowed to re-enroll.

## **ACADEMIC DISHONESTY**

FIRE School of Ministry students are awarded their certificate or degree in recognition of successful completion of coursework in the program. Everyone is expected to earn his/her certificate or diploma through the application of diligent, personal effort. Consequently, any plagiarism on assigned papers, cheating on quizzes or exams, or falsifying course affidavits, constitutes dishonesty. Students who engage in academic dishonesty will be penalized.

## Plagiarism

Plagiarism is the unacknowledged quotation of the exact words of a published text or the unacknowledged borrowing of original ideas by paraphrase from a published text. A student using information in written papers from books, articles, or oral or online sources must use footnotes or endnotes or cite sources within the text, endnote page, or bibliography, as determined by the instructor. Such sources will serve to reference direct quotations, generally unknown ideas and facts, or the form, structure, and/or style of a secondary source to the author, including information that has been reworded and is not a direct quotation. Citations are not required for widely known facts and the student's firsthand thoughts and observations.

## Cheating

In a scholastic environment, cheating includes the following:

- Giving or receiving answers during quizzes or exams
- Soliciting another person to take a quiz or exam
- The actual taking of any quiz or exam for another student

- Writing a term paper or assignment for another student
- Using course materials or answer keys in an unauthorized manner
- Looking up answers to questions online while taking a test
- Presenting another person's assignments as one's own
- Falsifying a course affidavit

## Penalties for Plagiarism or Cheating

The penalty for plagiarism or any of the above cheating infractions will depend on FSM's assessment of the severity of the offense, and may include receiving an "F" with the numerical value of zero on the assignment, receiving an "F" as the final course grade, or possible suspension or dismissal from the school.

## Academic Dishonesty Appeal Process

A student who feels he/she has been penalized unfairly for Academic Dishonesty may choose to appeal the penalties. Within forty-eight hours following the penalties, a student may submit an emailed appeal to the Academic Department with detailed documentation to validate the appeal. The Academic Department, in coordination with the President, will review any such appeals and make a final determination.

## **LEARNING DISABILITIES**

Students with documented learning disabilities may request accommodations by contacting the Director of Academic Affairs. The Director of Academic Affairs will provide the student with FSM's complete learning disability policy and will work with the student to ensure that appropriate, adequate, and reasonable accommodations are provided.

## PROGRAM REQUIREMENTS

Students must meet the program and graduation requirements as outlined in the catalog that is in effect at the time of the student's first term. In the case that a student misses one full year of school, the student will be required to complete the requirements as outlined in the most current catalog, upon their re-enrollment.

#### ACADEMIC ADVISING

Students who have questions regarding registration, graduation requirements, or other academic concerns, may contact the Academic Department for academic guidance. Although the Academic Department provides such guidance and monitors student progress, responsibility for fulfilling all program and graduation requirements rests solely upon each individual student.

## **ACADEMIC PROGRAMS**

## CERTIFICATE IN PRACTICAL MINISTRY

The *Certificate in Practical Ministry* can be completed in as little as one year. To complete the program students must earn at least 30 credits from required credit categories, including 4 credits of practical ministry.

#### ASSOCIATE IN PRACTICAL MINISTRY

The Associate in Practical Ministry can be completed in as little as two years. To complete the program the student must earn at least 60 credits from required credit categories, including 8 credits of practical ministry.

#### PROGRAM OBJECTIVES

During their time at FIRE School of Ministry, students will be exposed to multiple settings that will assist in their leadership development, including the following dynamics:

- Enter into a more intimate and mature walk with God.
- Know the Word on a more advanced level.
- Receive practical tools to live and minister through the power of the Holy Spirit.
- Be empowered to live a radical, holy life.
- Build solid confidence in your identity as God's child and a new creation.
- Feel greater release into your calling and destiny.
- Cultivate a radical prayer life.
- Serve as a solid academic foundation for those who wish to continue their studies after FSM.

#### PROGRAM COMPONENTS

## Online Classes

Students will take online courses, which typically require the student to listen to recorded class lectures, and complete tests and/or class assignments.

## **Practical Ministry Requirements**

Students will be required to complete practical ministry requirements in their local area, in conjunction with a local church, or other Christian ministries.

## Live Video Faculty Mentoring

FSM provides periodic live faculty mentoring sessions, where the student body can interact online with a faculty member. Participation in these sessions is encouraged, but not required.

#### MINISTRY PRACTICUMS

FIRE School of Ministry students are required to complete ministry practicums in conjunction with ministries or churches in the student's local area. Each practicum credit requires the student complete 30 hours of ministry within a three-month period to receive full credit. Students are awarded in order: PM161, PM162... up to PM168, after completion of each ministry practicum.

## **MINISTRY INTERNSHIPS**

Students may apply to participate in an internship, to earn credits in place of up to 4 Ministry Practicum Credits (PM165-PM168), and towards up to 4 credits of Elective Credits (total of up to 8 credit hours earned).

## **FAILED COURSES**

If a student fails a required course, he/she must retake the course and receive a passing grade before becoming eligible to receive the degree.

#### **FACULTY MEMBERS**

FSM faculty members come from a variety of ministry and church backgrounds, and all of them have decades of ministry experience. Students will benefit from being taught by instructors with unique perspectives, experiences, and giftings.

## ACCREDITATION /ARTICULATION AGREEMENTS

FIRE School of Ministry is not accredited at this time. Nevertheless, FIRE School of Ministry does place a high value on academic excellence and seeks to instill a sound biblical worldview and an advanced level of biblical understanding into all our students. All our faculty members have years of ministry experience, and several of them are active in biblical scholarship and academic research and writing.

FIRE School of Ministry has partnered with three accredited universities, Ecclesia College, The King's University, and Southern Evangelical Seminary, all of whom will accept many FSM credits for transfer. FSM is also working to obtain additional agreements. This will help enable students to pursue further education after studying at FSM. Please see the Registrar for more specific details.

## **COURSE DESCRIPTIONS**

## BIBLE AND THEOLOGY

## BT101—Old Testament Survey

This course will familiarize the students with each book of the Old Testament, with special attention to: (1) key themes of each book, especially as they relate to Israel's biblical history and to God's overall salvation plan; (2) important people and events, and how they further the overall purposes of God; (3) unique features of each book, including background information and key Scriptures; (4) recognizing patterns of how God deals with His people, and how that relates to a modern community of radical believers.

## BT102—New Testament Survey

This course will familiarize the students with each book of the New Testament, covering the background information and content of the books within their historical context as provided by the Book of Acts.

#### BT103—Doctrinal Foundations I

An introduction to major doctrines of the Christian faith. Discussions on the doctrines of revelation, God, man, sin, and salvation will emphasize the foundational nature biblical truth plays in the life of the believer, including explanations of how each doctrine affects us in our daily lives as Christians.

## BT104--Bible Study Tools

Bible Study Tools is designed to equip students with Scripture knowledge and Bible study methods that will make them more effective in the use of Scripture in daily devotions, personal study, and ministry to others. Students will learn different ways to study the Bible, including genre study, book outlining, and observation of individual texts.

#### BT105—Jewish Roots

A course examining God's eternal purposes for Israel, anti-Semitism in the historic and contemporary Church, and the Jewish roots of the Christian faith.

## BT106—Doctrinal Foundations II

An introduction to major doctrines of the Christian faith. Discussions on the doctrines of the Holy Spirit, the church, and last things will emphasize the foundational nature biblical truth plays in the life of the believer, including explanations of how each doctrine affects us in our daily lives as Christians.

## BT111—Introduction to Apologetics

A general introduction to apologetics. Students will be both strengthened in their faith, and better equipped to answer various questions they may encounter in ministry. Topics will include the reliability of scripture, evidence for the resurrection of Jesus, Jewish apologetics, creation and evolution, and the problems of evil and suffering.

## BT203—History Makers

A survey of the most important acts of God in the history of the Church, focusing on the people God used more than the events themselves. The purpose is to train students to become history makers through the following three emphases: identifying the characteristics that make one a history maker; plotting God's advance of the church through history until the present day; recognizing our unique place in history in anticipation of what God is about to do.

## BT206—The Book of Proverbs

This course gleans key insights from the book of Proverbs into the wise and blessed life grounded in the "fear of the Lord." It focuses on the major issues addressed in Proverbs: the tongue, pride, anger, sexual temptation, laziness, greed, wise decision-making, etc.

### BT207—Studies in First Corinthians

This course is an exposition of 1 Corinthians. We will use it as a window into the mind of Paul as an apostle in order to understand the foundation and constitution of an authentic, NT church.

## BT219—Biblical Exegesis

The course teaches students the steps in the exegetical process, including principles of biblical exegesis and the use of lexicons, concordances, and standard tools and reference books. Knowledge of the biblical languages is not necessary.

## BT220—Acts

The class will work through the book of Acts, highlighting key themes and biographical characters. Emphasis will be on the character and behavior of the emerging church as it is described in Acts. Students will learn what first century church life was like and be encouraged to repeat the faith, power, and community life of the church of Acts.

## BT223—Ephesians

This course will focus on the epistle of Paul to the Ephesians and the supernatural message to the Church therein contained. We will exegete this writing in its original time of delivery and context, as well as explore how and why it still speaks loudly and authoritatively to this day and Church age.

## BT225—I & II Timothy

This course will focus on the epistles of 1 & 2 Timothy. In this course we will explore the two epistles written by the Apostle Paul to his spiritual son Timothy. We will exegete these writings in their original time of delivery and context, as well as explore how and why they still speak apostolically and authoritatively to our present day and Church age.

## BT226—Exposition of Romans

A comprehensive study of the entire book of Romans to determine the overall teaching and major themes of the book and their current application to believers both corporately and individually. Key doctrines will be discussed in consideration of their function within the larger literary and rhetorical structure of Romans.

#### BT228—The Book of Hebrews

This course will systematically go through the Book to the Hebrews, and expound on key themes of the book, including: the exaltation and superiority of Jesus – the Son of God; the danger of going back to Judaism without Jesus; that only through the cross and the Messiah can things be made perfect; and the need for perseverance.

## **CHRISTIAN FORMATION**

## CF101—Foundations for Intimacy with God

This class is designed to bring you into the reality of a lifetime journey of seeking and experiencing God's love, beauty, nature, and presence. This will be accomplished not only by informing you about God through teaching Scriptural principles, but by teaching you how to experience God and make intimacy with Him the foundation of your life.

## CF108—Principles of Holiness

The Scriptures teach that without holiness, no one will see the Lord. This course provides an indepth biblical understanding of the nature of holiness, offering practical helps to holiness, as well as guidelines for avoiding legalism and walking in grace.

## CF115—The Love of God

This course is designed to expose people to a Biblical theology of God's love. We will be examining both the Old and New Testaments, the viewpoints of the Apostles, as well as Jesus' example and testimony. We will seek to establish a Biblical definition of love, and through Scripture, determine what God's love for us is like. We will endeavor to provide an answer to the question: why does God love us?

## CF116—Foundations of Prayer

This course seeks to equip the student with tools necessary for an effectual prayer life. The importance of faith and perseverance in prayer will be discussed, and many hindrances to prayer will be exposed.

## CF200—Leadership

One of the keys to strong, revived, New Testament churches is solid, godly leadership. This course will present different possible styles of leadership and teach the qualities of effective, scriptural leadership models.

### CF201—Relationships and Communication

This course will teach students how to build godly relationships by learning how men and women communicate. Both married and single students will benefit by learning the different degrees or levels of communication. This class will cover marriage expectations, what makes a marriage work, personality differences, how to work and play well together, the root causes of anger, and the key to resolving interpersonal conflicts, whether single or married.

## CF202—New Testament Life: Matthew

This class is an exposition of Matthew's gospel that will focus on the overall purpose of Jesus' life and ministry as establishing God's Kingdom on earth. Teaching and discussion will focus on dynamic interpretation of the gospel, and practical equipping for our own, Kingdom-centered life, relationships, and ministry.

#### CF203—Foundations of Intercession

This course seeks to take the student into the very heart of intercessory prayer. The biblical meaning of intercession, identification, and travail in the Spirit will be discussed, and other relevant topics such as fasting, and the burden of the Lord will be covered.

## CF204—How to be Led by the Spirit

This course seeks to equip the student to recognize and respond to the Sprit's leading. The purpose of the gifts of the Spirit, and the role of dreams, visions, and the inner witness in hearing from God will be discussed.

## CF205—Spiritual Warfare

This course seeks to equip the student for violent warfare against the devil. Attention will be given to the nature of the battle, the weapons we have been given, and God's involvement in the battle.

## CHRISTIAN WORLDVIEW

## CW103—The New Jesus People

God's will for his people is that they be conformed to the image of his son, Jesus Christ. This dynamic course approaches the foundational-discipleship topic of our identity in Christ as new creations. From a historical standpoint we will discuss the vision and prophecy that called for a "New Jesus People," 40 years after the original "Jesus People" began. From a scriptural standpoint we will discuss Jesus as the Son of God, Jesus as giver of new life, grace, and our call to bear his image.

## CW114—The Jesus Revolution

The objectives of this course are: to define the essential meaning of revolution; to help students develop a revolutionary mentality; to outline the main qualities of a Jesus revolution; to impart a vision for a Jesus revolution in this generation; to identify where the church needs revolutionary change. Subjects covered in this course include: Jesus the Revolutionary, Revolution in the Church, Principles of Revolution, God's Counterculture Revolution, Strategies for the Jesus Revolution, The Role of Music in the Revolution, and Knowing the Times and Seasons.

#### CW115—World Missions

A practical and theological study of the believer's calling to reach the nations with the Gospel of Jesus, including a historical overview of missions and an analysis of contemporary need.

## CW118—Apostolic Foundations

This course will focus on the subject of being an apostolic people and the themes that surround this all-important dynamic. We will explore multiple foundational issues that are predicated upon the doctrines and patterns that made the New Testament Church in the book of Acts an apostolic expression of God's purposes in the first century, as well as throughout the ages. We will also explore the reasons why the church in this hour must reclaim and properly appropriate this mindset and way of living as unto the Lord, as well as the apostolic pattern of doing the ministry of Jesus in the earth.

## CW119—Revival History & Characteristics

An overview of the subject of revival, beginning with revival in the Scriptures and continuing through Church history, emphasizing the major characteristics of spiritual revival and awakening.

## CW120—Contemporary Doctrinal Errors

This class focuses on two key issues facing the church today: the error of hyper-grace and the question of can you be gay and Christian? It first lays out the glorious power and reality of God's grace and then goes on to describe the exaggerations and errors found in the modern grace movement, answering questions such as, "Has God already forgiven our future sins?" and, "Does the Holy Spirit convict believers of sin?" It also tackles the urgent question of homosexuality and the Bible, providing compassionate, practical, and scripturally based responses to this unavoidable subject.

## CW205—Apostolic Church

What is the Church? What is God's intended identity for His people according to the New Testament? How can we recover this identity from the many layers of human traditions and denominational fads? This course seeks to examine and answer these questions through Scripture and a prophetic understanding of the present season.

## CW206—The Image of God and the Beasts of the Field

Marrying the concepts of holiness and grace, this course describes the process whereby God takes His children, who are made in His image, and transforms them into the image of His Son.

## **MINISTRY STUDIES**

## MS109—Baptism & Gifts of the Spirit

A systematic study of the purpose and place of the ministry of the Holy Spirit in the contemporary Church, describing in detail the Spirit's various manifestations and gifts.

## MS114—Prophets and Prophetic Ministry

This course seeks to explain the true role of the prophetic ministry. The purpose, nature and power of the prophetic word will be discussed, along with how prophecy should be evaluated.

## MS116—Principles of Evangelism

This class aims to ignite a passion for the lost and equip students with the qualities and strategies of a soul winner to effectively win our world in the last days' harvest.

## MS211—Shepherding God's Flock

A course focusing on the importance of having the heart of a shepherd as expressed in the Word of God. Topics covered will include: characteristics and qualities of a shepherd's heart, the shepherding qualities of Jesus, and the unique calling of a shepherd.

## MS212—Cross-Cultural Communication

The purpose of this course is to equip the student in evaluating their own culture, and other cultures, in order to effectively communicate in many areas, specifically the gospel.

## MS213—Personal Discipleship

The primary objective of this class is to explore the biblical concept of what it means to be a true disciple (follower of Jesus). Upon completion of this class students will be able to: recognize and implement various scriptural texts that directly deal with the subject of discipleship in the context of the New Testament; properly teach and implement the concepts of being a disciple and making disciples; understand the process from evangelism to disciple-making (spiritual reproduction).

## MS222—Principles of Biblical Counseling

This course is designed to teach the basic principles of counseling such as the purpose of counseling, the goals of counseling, confidentiality and how to conduct a session. We will also examine specific counseling issues and focus on inner healing and deliverance.

## MS223—Countering the Counter Missionaries

This course is focused on Jewish Apologetics, and provides systematic teaching, grounded in solid biblical and Jewish scholarship, that responds to all the major objections brought against the Messiahship of Jesus, demonstrating from the Scriptures that he is the promised Redeemer of the Jewish people and the Savior of the world.

## MS238—Principles of Praise and Worship

A course examining the biblical foundation for praise and worship, including both major historical developments and renewal trends in the contemporary, Spirit-filled Church. This course will also examine the importance of praise and worship in one's personal life.

## MS239—Angels, Demons, and Deliverance

This course seeks to discuss the biblical teaching regarding angels, demons and deliverance. Tactics of the enemy will be exposed, and the role of deliverance in the life of the believer will be discussed.

## MS240—Introduction to Islam

This course will provide a basic introduction to Islam and help equip the student to be an effective witness when ministering to Muslims.

## PM161-PM168 - Ministry Practicum

A ministry practicum completed in conjunction with ministries or churches in the student's local area. Each practicum credit requires the student complete 30 hours of approved ministry within a three-month period to receive full credit.

## PM260 – Ministry Internship

The ministry internship is an opportunity for students to acquire supervised practical ministry experience and, at the same time, to make a valuable contribution by serving in a ministry context. ## **DOCTRINAL STATEMENT**

We believe in the verbal, plenary inspiration of the Bible, both the Old and New Testaments (2 Tim 3:16; Heb 4:12; I Pet 1:23-25; 2 Pet 1:19-21).

We believe in the one triune God co-existing in three persons: the Father, the Son, and the Holy Spirit (Mat 3:16, 17; 28:29; John 17).

We believe that man, in his natural state, is a sinner, lost, undone, without hope in the world, and without God (Rom 3:19-23; Gal 3:22, Eph 2:1,12).

We believe that Jesus is God, come in the flesh and that He is both fully divine and fully human, the Son of God (Luke 1:26-38; John 14:1-3; Acts 2:36, 3:14, 15; Phil 2:5-12).

We believe the only way to be saved is through the shed blood of Jesus Christ, who died for our sins and was raised for our justification (Acts 4:12; Rom 4:1-9, 25; 5:1-11; Eph 1:3-15).

We believe that the same Christ Jesus who walked the earth in His fleshly body has been raised from the dead and has ascended to the Father and is presently serving as head of the church on earth, bringing it to purity and maturity, and interceding for the saints (Luke 24:39-43; John 20:24-29; 14:1-6; Romans 8:34; Eph 4:11-13; Col 1:18; Phil 1:6; Rev 19:7-8).

We believe in the visible, bodily, premillennial return of Christ Jesus to this earth, to gather His Church (Bride), and to judge the world (Acts 1:10, 11; I Thessalonians 4:13-18; 2 Thessalonians 1:7-10; James 5:8; Revelation 1:7).

We believe that in conjunction with the return of Jesus, the people of Israel will turn to God and be saved (Mat 23:39; Rom 11:15). The church is not spiritual Israel; it will enjoy the promises given to Abraham along with natural Israel, not in place of it. The church and Israel remain distinct, but believing Jews and believing Gentiles are united as one people of God through the redemption that is in Messiah Jesus, the Son of God. With this in mind, the church should love Israel as it loves itself, should pray for Israel, should minister with the understanding that their Savior is Israel's Messiah, and should pursue the salvation of Israel.

We believe that the terms of salvation are repentance toward God and a personal, heartfelt faith in the Lord Jesus Christ, which results in regeneration of the person. This salvation is entirely by the grace of our Lord and not of works. Works are excluded except as fruit of salvation (Acts 3:19, 20; Romans 4:1-5; 5:1; 10:9-10; Ephesians 2:8-10).

We believe that the Church of Jesus Christ is a body of believers who have Jesus as their head; who assemble to worship, who carry forth the great commission, and who minister as the Holy Spirit leads (Mat 16:18, 28:19, 20; Acts 2:20-28; Eph 4:15; 5:22-32; I Tim 3:15).

We believe that the two ordinances of the Church which are commanded by Christ are Baptism, by immersion in water in the name of the Father, Son and Holy Spirit (Mat 28:19-20; Acts 8:38; Rom 6:1-4; 1 Pet 3:21); and the Lord's Supper, a memorial of the death, resurrection and second

coming of our Lord Jesus Christ (Luke 22:13-20: 1 Cor 11:23-26).

We believe that believers should live, as the early disciples did, a life separated from the world and unto Christ and to set standards of conduct that exalt our Lord and His Church. A life of holiness and obedience to God is not optional, but is commanded by Jesus and the apostles as a requirement for those who will enter the kingdom of God (Mat 7:21; 16:27; Rom 12:1-3; 2 Cor 6:17; Gal 6:14; Eph 5:11; Col 3:17; Rev 20:12). Holiness is not prerequisite to, but evidence of, salvation, and as such it is always present among those who are saved (Heb 12:14).

We believe that the Scriptures clearly set forth the doctrines of eternal punishment for the lost and eternal life for the saved (Mat 25:34, 41, 46; Luke 19:19-31; John 14:1-3; Rev 20:11-15).

We believe the Holy Spirit to be the third person of the Trinity whose purpose in the redemption of man is to convict men of sin, regenerate, indwell, and guide the believer into all truth, and give gifts to believers as He wills, that they may minister as Christ would, to men. We believe that any local congregation that yields to the Holy Spirit should experience the manifestations of all the Spiritual gifts mentioned in 1 Cor 12:8-10 (Luke 11:13; John 7:37-39, 14:16, 17, 16:7-14; Acts 2:39-48).

We believe that Baptism in the Holy Spirit, primarily evidenced by speaking with other tongues as the Spirit gives utterance, is for all believers as promised by John the Baptist (Mat 3:11), Jesus (Acts 1:4, 5, 8), and Peter (Acts 2:38-41) and as witnessed by the early disciples of the Lord Jesus Christ (Acts 2:1-4; 10:44-46; 19:6).

We believe that God uses doctors, medicines, and other material means for healing, but that divine healing is also provided in the atonement (Isa 53:5) and may be appropriated by laying on of hands by elders (James 5:14-16) or by believers (Mark 16:18), by the prayers of any believer gifted for healing the sick (I Cor 12:9), or by a direct act of receiving this provision by faith (Mark 11:23).

We believe that the foundation of the New Testament Church is the apostles and prophets, Jesus Christ being the cornerstone. We also affirm that the five-fold ministry of apostles, prophets, evangelists, pastors, and teachers, will continue until Jesus returns (Eph 2:20-22; 4:11-16).

We believe that leadership in the church should emerge as the gifts of God become evident, that these leadership gifts include, but are not limited to elders and overseers, and that all leaders in the body of Christ are given to serve the body, not to be served, and to facilitate the will of God, not their own will, being realized among the saints under their care.
